1. General Presentation—Reinventing the ORU: Research as Teaching and Public Service

The Institute of Governmental Studies is the University of California's primary center for interdisciplinary study and research in politics, government, and public policy. IGS works with undergraduates, graduate students, and scholars across the campus and around the world to further the University's primary goals of teaching, research, and public service. While most ORUs have a narrow research focus, IGS has long pursued a broader mandate. We believe that research benefits from the synergy generated by teaching and public service, and our experience confirms that belief. This synergy is not a recent discovery. At its birth in 1919 as the Bureau of Public Administration, IGS committed itself to use its resources—its library, its research capacity, its publications program, and its teaching and training—to help solve “the important problems of government administration.”

Among its many activities, IGS:

- Encourages undergraduate research by providing faculty guidance and administrative and financial support.
- Provides faculty expertise to state legislators and commissioners and sponsors conferences on campus and in Sacramento to examine key policy questions from political regulatory reform to constitutional revision and digital democracy.
- Works closely with the electronic and print press to see that the public is better informed about electoral decisions and governmental actions.
- Offers university-wide leadership in assembling colleagues to study issues such as recall elections and term limits, and to explore new research initiatives.
- Publishes books that help to define state politics from the governor's race to the changing impact of racial and ethnic politics in California.
- Gives financial and intellectual support to journalists who write major biographies of state political leaders including Phil Burton, Willie Brown, Jesse Unruh, Pat Brown, and Earl Warren.
- Provides a campus forum for leading figures from the world of politics and public affairs.

Every program IGS presents is open to the public. Every research project incorporates a role for students. We are constantly inventing new ways to disseminate the results of state supported research to those people who can best put it to use. A brief outline of these efforts follows.

Teaching, Training & Research

Graduate Students

ORUs are not teaching units per se. But invaluable instruction can take place in a research environment that teaches students the art of discovery. IGS provides financial support, faculty guidance, and a campus home to 45 doctoral candidates. These students work with IGS scholars as Graduate Student Researchers or serve as Teaching Assistants in classes taught by IGS faculty and associates. At IGS, teaching, training, and research are all part of an open-ended, ongoing process that occurs in informal discussions in faculty offices or impromptu talks over tea as well as in formal seminars, at conferences, and in structured research projects. Some recent examples:

- Ongoing seminars and colloquia offer selected graduate students the opportunity to work closely with faculty members in organizing meetings that bring distinguished authors and scholars to campus. IGS now hosts five such series, focusing on American political history, American politics, positive political theory, the relationship of business and government, and race, ethnicity, and immigration.
- IGS welcomes state legislators and other political practitioners to campus on a regular basis, allowing graduate students and others to interact with some of the leading political figures in the state. In the past year, for example, Assemblyman Mark Leno spoke about the struggle to enact his bill that would legalize gay marriage, and Rob Stutzman, director of communications for Gov. Arnold Schwarzenegger, discussed the governor's agenda.
- Political Science Ph.D. candidate Matt Grossmann teamed up with Christine Trost, who completed her doctorate in political science at Berkeley in 2000, to edit *Win the Right Way: How to Run Effective Local Campaigns in California*, a primer for first-time candidates. The book is based on research by the IGS Center on Campaign Leadership, which brought together practitioners, scholars, and students to study the best practices of political campaigns. It was published by the IGS Berkeley Public Policy Press.
- Teaming up with campus and governmental cosponsors, IGS held a town meeting on transatlantic trade and economic relations. The discussion addressed a variety of topics, including how to promote growth, spur innovation, and eliminate impediments to further economic integration.

- The IGS Center on Institutions and Governance, with nine cosponsoring partners, organized a major conference on democracy and global Islam. The goal of the conference was to promote a better understanding of Islam as a way of informing the public about major national and international issues.
- The ninth annual Travers Ethics Conference, sponsored by IGS in conjunction with the Institute of International Studies, brought together scholars and practitioners to discuss the laws and practices that govern wartime behavior.
- IGS and Worcester College (Oxford) combined to stage a three-day conference on the United States Senate. The event, organized by Nelson W. Polsby of the IGS faculty and Alan Ware of Worcester College, was held in the newly constructed Rothermere American Institute at Oxford. One topic of focus was the history and importance of Senate leadership positions.

Undergraduates

- The IGS Center on Politics provides support and assistance to undergraduate political groups, from partisan organizations such as the College Republicans and the Young Democrats to nonpartisan groups such as the *Berkeley Political Review*. IGS Senior Consultant Jerry Lubenow advises the staff of the *Review*.
- Students interested in practical political experience benefit from the Cal in Sacramento Platinum Fellowships program, which is administered by the IGS Center on Politics. This past summer, the program sent 15 Platinum Fellows to work in the legislature, the governor's office, state agencies, and media organizations. This fall, we appointed a distinguished team to coteach a political science course that will prepare next summer's batch of fellows—former state Sen. Patrick Johnston and longtime senior legislative staff member John Decker. Both Johnston and Decker have been visiting fellows at IGS and offer tremendous leadership to the Platinum Fellowship program.
- IGS employs more than 20 undergraduates in a variety of positions. Many perform administrative tasks, but some are hired to conduct research under the auspices of faculty members or graduate students.
- Former Assemblyman and IGS Legislator-in-Residence Ted Lempert was appointed to teach the popular political science course in California politics, which has long been supported by IGS. The best research by students in the class is excerpted in the IGS *Public Affairs Report*.
- Veteran political consultant Dan Schnur once again taught his popular course in political strategy, offering to motivated students the lessons of a long and distinguished career in the political trenches.

Public Service

IGS has a strong orientation to public service and views its mission to educate as extending beyond its students to the people of California and to their representatives in state and local government. The ability of IGS simultaneously to serve the Capitol, the campus, and the community has been significantly strengthened with the creation of programs such as the Center on Politics and Public Service and the Berkeley/Sacramento Program. Among the Institute's many service activities:

- The IGS Center on Politics held its 24th annual Review of the Presidency. The event, jointly sponsored with the UC Berkeley Extension, brought together a distinguished panel, including *Newsweek* writer Eleanor Clift and former Secretary of Labor Robert Reich, to discuss the status of the Bush administration.
- The Institute's *Public Affairs Report* is sent to thousands of readers across the country, chronicling IGS research, events, and writing. It is read and regularly praised by scholars, journalists, and public figures.
- Media representatives in the Bay Area, across California, and throughout the nation regularly call upon IGS experts to comment on issues of pressing public concern. A count of media citations over the past decade found IGS mentioned hundreds of times, far more than the next most cited Berkeley social science ORU.
- While many ORUs have closed their libraries, the IGS Library remains a unique resource on a vast range of public issues for scholars, students, public officials, and the general public. During election years, including this year's special election, the library's website election "Hot Topics" provide especially timely public education.
- As more and more ORUs have ceased their efforts at publishing, IGS Press and its Berkeley Public Policy Press imprint have become an important campus resource, publishing materials for other ORUs, schools, and departments.
- The Berkeley/Sacramento program brings legislators and public officials to campus to meet with students, faculty, and the public. The Berkeley Briefings component of this program brings faculty members and other experts to Sacramento to brief senior legislative and executive-branch staff.

2. Director' Report 2004-05: Bruce E. Cain

It was another busy year for the IGS, marked by some important transitions. Sadly, one of our longtime former research scholars, Professor Emeritus Martin Landau, passed away on December 27, 2004. Professor Landau was a renowned scholar of organizational theory and founder of the Hong Kong Project, a program that brought many senior level administrators from Hong Kong to the IGS to learn about the application of Professor Landau's theories to practical administrative decision-making.

Another important transition for the IGS is the recent appointment of Professor Jack Citrin as Associate Director of the IGS. Professor Citrin has served on the IGS Faculty Advisory Committee for many years and has successfully run the IGS-sponsored seminar: Colloquium on Race, Ethnicity, and Immigration. With the IGS director taking on a new responsibility in Washington at the UC Washington Center, Professor Citrin will provide day-to-day faculty leadership for the Institute.

Lastly, Jerry Lubenow, our director of publications and also director of the Center on Politics decided to retire in July 2005. Lubenow's invaluable leadership in running programs at the IGS, editing and writing for the *Public Affairs Report*, and raising funds and essentially saving the undergraduate Cal-in-Sacramento internship program have been critical to the IGS success. He will be missed, but not entirely, since we plan to retain Jerry as a consultant for IGS activities in the future. His replacement is Ethan Rarick, formerly of the *Contra Costa Times* and most recently the author of a highly acclaimed biography of former Governor Pat Brown (written at the IGS).

On the research and grant side, 2004-05 was a very active year. We received two grants for studies related to redistricting. One from the James Irvine Foundation for \$115,000 that will look at the prospective for redistricting reform in California, and in particular, what it would take to restore some measure of competitiveness to California elections. The other, a grant for \$162,000 from the JEHT Foundation, will collect and analyze data from as many states as possible, hoping to trace the link between safe seats and polarization. The PI for both of these grants is the IGS director. Professor Margaret Weir (Sociology & Political Science) was awarded a major grant from the Robert Wood Johnson Foundation (i.e., \$275,000) to study federalism and strategies for health care reform in America. In addition, two of our scholars received awards from the Russell Sage Foundation: Irene Bloemraad (Sociology) received \$34,895 to study the role of community organizing in immigrant political incorporation, and Taeku Lee (Political Science) received \$33,257 to examine immigrant incorporation and party identification among Latino and Asian Americans.

Another important research development was the founding of the Election Administration Research Center (EARC), headed by Karin Mac Donald. Funded by \$500,000 from the settlement of a lawsuit brought by the state against Diebold Election Systems, this center is dedicated to the systematic study of election administration. The Center's first project is to work with local and state election officials to improve methods of poll worker training. Given the large number of votes that are lost in every election to mistakes in filling out ballots, this project could potentially help re-enfranchise many voters.

Research sponsored by the IGS has won several notable awards recently. Thad Kousser's dissertation on term limits won the APSA's 2005 Alan Rosenthal Prize for research on state politics. Henry Brady and David Collier won the 2005 Giovanni Sartori Prize of APSA's qualitative methods section for their IGS monograph, *Re-thinking Social Inquiry: Diverse Tools, Shared Standards*.

The Pew Charitable Trusts has funded the IGS quite generously in recent years. The President and CEO, Ms. Rebecca Rimel, visited the IGS in November 2004 and gave a public lecture entitled "Off the Bench and Into the Game: Democracy Isn't a Spectator Sport." The IGS hosted a luncheon in her honor attended by the many of the Berkeley recipients of Pew grants and senior campus officials.

Last year marked the inaugural academic season for the Center on Institutions and Governance (CIG), headed by Professor Robert Powell (Political Science) and Heddy Riss. CIG sponsored a number of well-attended conferences, including an all day event assessing the global extension of Islam and its implication for democracy, a symposium on the status of democracy in Nepal, seminar on the vote for the EU constitution and another on agricultural policy in the US and Europe. The Center extends the IGS interest in institutional design to non-American and "weakly institutionalized" (e.g. international and supranational) settings. In addition, we have partnered with the Institute of European Studies in providing a program for the US Department of State in December 2004 on "Transatlantic Economic Relations" and a talk by the French Ambassador to the US, Jean-David Levitte, on US-French relations. We also partnered with the Center for British Studies to host a British General Election Night on May 5, 2005.

At the same time, we did not neglect our ongoing, traditional American and Californian interests. During the fall 2004 election season, we ran ten events open to students and members of the university community covering the debates, polling issues, campaign strategies, issues and election results. In April 2005, we held our 24th Annual

Review of the Presidency. Closer to home, in January 2005 we co-sponsored a conference on housing dispute resolution issues and NIBYism with the Haas School's Berkeley Program on Housing & Urban Policy and a panel discussion around the publication release of Ethan Rarick's Pat Brown biography led to a panel discussion of the book, featuring Bill Boyarsky of the *LA Times* and Peter Schrag.

The IGS promoted graduate student research with two conferences. The 2nd Annual Political Science Graduate Student Conference on May 2, 2005 featured 12 papers with faculty commentators, followed by a much needed happy hour. The IGS also cosponsored with Stanford University in the fall another all-day event, with eight papers presented by graduate students from both campuses. Both programs provided invaluable opportunities for the graduate students to get feedback on their research and practice for the job market.

The IGS Library hired Nick Robinson, formerly with the campus Public Health Library, to replace Terry Dean as our Public Services Librarian. Over the past year the IGS Library continued to expand its Web presence, both by linking to information resources and by providing substantive content. The Library created online profiles of all California statewide ballot propositions appearing before the voters in 2004 and 2005. The profiles, part of the Library's *Hot Topics* series, provide an impartial overview of each proposition, with links to key websites, news accounts and reports. The *Hot Topics* series provides timely information on California public policy issues to interested citizens and policy makers. Under the direction of Librarian Nick Robinson, the Library instituted a process for identifying and capturing Web-based policy reports and studies, called the California Policy Box (inbox.berkeley.edu).

After 86 years, IGS still leads the way in advancing interdisciplinary research and public service in American politics and public policy for the campus.

5. Publications

A Tradition of Academic Excellence

Publishing has been an integral part of the work of the Institute of Governmental Studies since it was founded in 1919. Through its semi-annual *Public Affairs Report*, working papers, monographs, and books, the IGS publications program disseminates the results of research by IGS scholars and colleagues across the campus. IGS publications are edited and designed for a diverse multidisciplinary audience on campus and off, in the United States and around the world. The *Public Affairs Report* has an international readership of more than 20,000—scholars, students, journalists, and leaders in government, politics, and public affairs. Published online as part of the California Digital Library, Working Papers provide rapid dissemination of research in progress and stimulate the review and discussion of draft reports and papers, preliminary analyses, and studies with a limited audience. In the last year alone, IGS Working Papers were downloaded more than 8,000 times. IGS Press publishes original analyses, essays, monographs, and edited volumes. IGS publications are the fruit of research by IGS faculty and associated faculty, visiting scholars, and colleagues at universities throughout the United States and around the world.

During the past year, IGS produced five new books.

- *Rethinking Social Inquiry: Diverse Tools, Shared Standards*, edited by UC Berkeley political scientists Henry E. Brady and David Collier, examines the relationship between qualitative and quantitative methods of research.
- *Win the Right Way: How to Run Effective Local Campaigns in California*, edited by Christine Trost and Matt Grossmann, provides a primer for first-time candidates.
- *Lessons from the Iraq War*, by Maj. Gen. Robert H. Scales, Jr. (ret.), offers the views of a distinguished former soldier about the current conflict in Iraq. The book is based on Gen. Scales's presentation of the Chester W. Nimitz Memorial Lectures in National Security Affairs.
- *A Little Noticed Revolution: An Oral History of the Model Cities Program and Its Transition to the Community Development Block Grant Program*, edited by John Sasso and Priscilla Foley, chronicles a major national effort to reverse the debilitating effects of decay in urban communities.
- *Turning Points and Ironies: Issues and Events—Berkeley, 1959-67*, by Ray Colvig, completed the Clark Kerr Memoirs Project by offering the views and experiences of the longtime director of the UC Berkeley public information office.

Breaking New Ground in Multidisciplinary, Multimedia Publishing

Three major innovations in recent years enabled IGS publications to expand its impact even while absorbing major budget cuts.

First, IGS Press negotiated a series of publishing partnerships that resulted in joint publications with the University of California Press, Rowman & Littlefield, and a well-known Italian academic press, Editori Laterza.

Second, the Press aggressively pursued partnerships with campus units that do not have the capacity to publish the products of their own research. This has resulted in volumes published with the Boalt Hall School of Law, the Graduate School of Public Policy, and the Departments of Military Education, among others.

In a third major shift, the IGS Faculty Advisory Committee, responding to a proposal from the Director of Publications, voted to create the Berkeley Public Policy Press, a multidisciplinary, multimedia publisher of time-sensitive, policy-relevant, social science research. The rationale for the Berkeley Public Policy Press (BP³) flows directly from campus efforts to improve the dissemination of research and expand scholarly communication through consolidation of services and the cost-effective use of new communication technologies. The mission of BP³ is to build a print and electronic bridge that links the research capacity of the University of California, Berkeley, to the public policy apparatus of state government, as well as to other academic researchers, students, the public policy community, the press, and the wider world of public affairs.

These shifts continue to enhance IGS' reputation as an important niche publisher of campus research. Berkeley's reputation as one of the leading research institutions in the world is well established. But its component parts, particularly the organized research units (ORUs), where much of the cutting edge research is done, often lack the requisite skills and capabilities to disseminate the results of their research efficiently and effectively. Even when funding organizations provide dissemination support, many units lack the capacity to ensure that their research results reach those audiences actively engaged in political discourse.

This lack of communication skills and technology is exacerbated as market pressures force commercial publishers and university presses to retreat from traditional venues for research dissemination, limiting the scholar's ability to publish research reports, specialized monographs, and edited volumes. Researchers who opt for electronic publication confront a medium with immense potential but daunting financial and technical entrance requirements.

As a multidisciplinary, multimedia publisher of policy relevant research, BP³ employs diverse technologies and techniques to help researchers communicate their findings to appropriate audiences. Using a range of traditional print and new digital technologies, BP³ provides an array of communications services, skills, and strategies tailored to the research product and the target audience. Over the years, the IGS publications program has created a consortium of campus units and worked with them to translate their research into language and formats that can be readily communicated to and understood by policymakers, the press, and the public.

BP³ has significantly enhanced the ability of campus units to communicate their research results. The press has developed an unique ability to publish research and analysis in high quality, peer-reviewed, carefully edited, moderately priced volumes and to keep the work in print. Over the past 10 years, the press has published roughly seven volumes a year and currently has 50 titles in print.

In recent years, and particularly over the past year, the IGS publications program has moved into electronic publishing, and its website offers a range of publications from monographs to edited volumes and working papers. IGS created a new Working Papers website, a Policy Papers site, and a site for electronically published monographs as part of the eScholarship Initiative of the California Digital Library. In addition, as older volumes with declining sales have gone out of print in hard copy versions, the Press has published digital versions online to ensure that the material remains available to scholars.

A Campuswide Partnership in Publishing

While upgrading its in-house publishing activities, BP³ has established a unique network of relationships with university and commercial presses that enable it to publish high-quality scholarly work in a variety of venues. Among the books published in the past year in collaborative relationships are *Rethinking Social Inquiry: Diverse Tools, Shared Standards*, published in conjunction with Rowman & Littlefield, a major publisher of academic work; and *Lessons from the Iraq War*, published in conjunction with the Berkeley Department of Military Education.

This list reflects the breadth and diversity that characterize the IGS publications program. Our basic goals remain unchanged: to assure the academic excellence and editorial quality of the books we publish, and to

strengthen our marketing to ensure that our books are widely available to scholars, students, and the general public. As the late UC President Emeritus Clark Kerr, who worked with BP³ to publish a series of monographs in connection with his memoirs, wrote regarding the work of the Press: “I am well aware of the unique niche this enterprise fills in the scholarly publishing world. . . . [It] adds immeasurably to the ability of campus ORU’s to disseminate rapidly the results of their research and to make available specialized works that are valuable in their field but not considered commercially viable.”

And as Prof. Margaret Weir, former chair of the IGS Faculty Advisory Committee, noted in a campus fact-finding and evaluative report prepared in connection with creation of the Berkeley Public Policy Press: “The IGS Press serves a vital niche market for scholarly work, publishing monographs that are not seen as commercially viable, an increasing problem for specialized work as academic publishers move away from publishing such work. IGS Press is uniquely able to publish books in a very short time frame. Compared with academic presses, which typically take more than a year to publish a book, IGS Press can produce a book within several months. This makes the Press especially valuable in publishing works that are time-sensitive, which is often the case with policy-relevant work.”

Item Line 107,127, & 167-Revenues and Student Fees The IGS Berkeley Public Policy Press includes \$122,000 earned income for prior years. Also includes the Diebold Settlement Agreement. IGS agreed to participate in a court-ordered settlement agreement with Diebold Election System. As part of this settlement IGS received \$500,000 to fund a research and outreach program based at IGS aimed at improving California’s electronic voting processes. Also, includes STIP income and Mental Health Conference.

Line Item 313 Graduate Student Researchers- IGS has no budgeted funds for graduate student researchers. Graduate Students Researchers are funded by nonbudgeted funds at IGS. Total graduate student researchers expense \$216,930 (includes salaries, fees, and benefits).
